ARTICLES

ARTICLE 2 Shall the School District raise an appropriation as an operating budget, not including appropriations by special warrant articles and other appropriations, and separately, the amounts set forth on the budget posted with the warrant, or as amended by vote of the first session, for the purposes set forth therein, totaling \$26,386,721 (twenty-six million, three hundred eighty-six thousand, seven hundred twenty-one dollars)? Should this article be defeated, the default budget shall be \$26,377,757 (twenty-six million, two hundred thirty-seven thousand, seven hundred fifty-seven dollars), which is the same as last year, with certain adjustments required by previous action of the Raymond School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only.
(This article does not include appropriations proposed under any other warrant article.)

ARTICLE 3 Shall the School District vote to approve the cost items included in the collective bargaining agreement reached between the Raymond School Board and the Raymond Education Association, which calls for the following changes in salaries and benefits at the current staffing levels from those paid in the prior fiscal year:

Food Service Equipment Capital Reserve Fund (established in 2006) \$39,010

No amount to be raised by taxation.
